- Intake of new batch of students is as per the norms of the State of Telangana through www.dost.cgg.gov.in (DOST). Online receipts and details of the students are collected, admission forms issued are filled by students and submitted to the college. Student's database is maintained by the college.
- The students who are allotted seats in the college through DOST are allotted under Mahatma Gandhi University, Nalgonda. Hall Ticket numbers allotted to students are unique to each one of them and any correspondence is viewed through university website.
- The students follow the examination patterns and timetables provided by the MGU. Internal marks and practicals marks are updated through the college login in the official site.
- The Hall tickets are downloaded for the examination on the dates earmarked by the University.
- Students access their results online from the official website.
- The students enroll themselves for scholarships through www.telangana.epass.cgg.gov.in and their details are maintained in the college.

6.3 Quality improvement strategies adopted by the institution for each of the following:

6.3.1 Curriculum Development

Since the college is affiliated to MGU, Nalgonda, it follows curriculum prescribed by the University and hence has no freedom in this context. However, faculty involvement in certain capacities gives the Institution a very limited involvement in curriculum development.

- Some of the faculty members are involved in course structuring and revision committees constituted by the University.
- Principal, Academic Co-ordinator, IQAC coordinator and all Heads of Departments monitor timely and correct dissemination of course content.
- Specialization of faculty is kept in mind during workload distribution.
- Several teachers are entrusted responsibilities as paper setters and examiners.
- Faculty members are appointed as external examiners for smooth conduct of practical examinations.

6.3.2 Teaching and Learning

- Teaching-learning process is facilitated through appointment of well qualified teachers.
- College library procures the revised editions of books, journals and magazines to update knowledge.
- Faculty members are encouraged to attend the seminars, workshops, FDP, refresher courses and conferences to update their knowledge in teaching and learning.
- Opportunities for the faculty for presenting the papers in conferences and seminars. Permissions and registration fee will be given by the college.
- Special attention is given and remedial classes are taken for slow learners and academically disadvantaged students.
- Regular feedback from students to improve teaching learning programme.

6.3.3 Examination and Evaluation

- Student evaluation through classroom interaction, unit tests, assignments, student projects, seminars, workshops etc.
- Efficient conduct of examination and unbiased evaluation.
- Academic and Examination branch ensures smooth conduct of examinations.
- Year-wise examination scheme for UG and semester examination scheme for PG are prescribed by the affiliating university, which also appoints examiners/ paper setters.
- Practical examinations are conducted by internal and external examiners appointed by the University.

6.3.4 Research and Development

- The College established a Research lab for inculcating research culture among the student and staff.
- Financial assistance is provided by the Management to teachers who pursue research, publish research papers in conferences and in workshops.
- Faculty members are encouraged to undertake minor and major research projects.

6.3.5 Library, ICT and physical infrastructure / instrumentation

- The Institution has a spacious library with a seating capacity of 100 students.
- Digital library is established with INFLIBNET facility.
- The library has more than 26,000 volumes of Textbooks excluding reference volumes, international Encyclopedia of social sciences and various Journals, along with National and Regional Newspapers.
- Various books on preparation for competitive and entrance examinations are available for the students' benefit.
- All books in the library are barcoded.
- Science have well-equipped laboratories with adequate safety measures.
- Sufficient class rooms with good infrastructure and well-equipped laboratories, playground, gymnasium and all basic facilities.

6.3.6 Human Resource Management

- Teaching and non-teaching staff are appointed by duly constituted committees.
- All employees are provided with benefits of E.P.F, E.S.I and casual leave, medical leave, maternity leave as per the government norms.
- Faculty members are encouraged to attend the workshops / seminars / conferences and are given O.D. facility.
- College administration always supports staff and students to optimize their work.
- All curricular, co-curricular and extra-curricular activities/ events are organized by concerned working committees constituted for the purpose by the Principal, IQAC coordinator and senior faculty members.

6.3.7 Faculty and Staff recruitment

- Faculty & staff recruitments are made by the Management Committee.
- A Selection Committee, consisting of University representative, subject experts and governing body members is constituted.
- The selection is ratified and approved by the University academic audit cell and the CCE.

6.3.8 Industry Interaction / Collaboration

The College has no formal collaboration with industry or any professional body. However, students are exposed to experiential learning through -

- Field trips to research centres, public offices, etc.
- Industry interface through the organization of Job Mela.

6.3.9 Admission of Students

Student's admissions are made on the basis of merit with the rules and regulations of Telangana state government. All the admissions are uploaded to the University and also to the Commissioner of Collegiate Education, Hyderabad.
